

Legal Aid Camp Report Location: Zilla Parishad High School, Kukatpally.

Date: 20th November 2023.

Introduction:

Access to justice is not confined to court based legal services but also extends to making people enlightening people about the rights and privileges under various enactments and welfare schemes.

The management and students (both 5YDC and 3YDC) of Ananntha Law College organized a legal aid camp at Zilla Parishad High School, Kukatpally, on 20th November, 2023. The main motive is to provide children with meaningful, effective, affordable, and age-appropriate legal assistance. This was done as a way of giving speeches and enacting skits.

Objective of legal services camp:

- Identifying the underlying issues of people, especially children and women.
- To spread awareness about welfare legislations and schemes.
- To address the legal problems of the people.

Program:

- School children of class 8 th, 9th and staff were present for the legal aid camp.
- As a mark of respect and gratitude, Principal, and faculty of Ananntha law college felicitated Head master of Zilla Parishad High School, Guru Chary Garu and in charge Narendra Reddy Garu.
- The programme was followed by Skits and song enactment by the students of Ananntha Law college, highlighting the pressing issues relating to the protection of rightsof girl and women.
- After the programme, Ms.B. Lakshmi Prasanna, had an interactive session with the children.
- Principal and the in charge of legal aid committee of Ananntha law college were felicitated to praise their achievement and success in organizing the legal aid camp.













Skit 1:

The gist of the story is as follows:

Siri an NGO Woman's Activist, notices a Struggling Couple with Pregnancy and enquires about their condition, and suggests them to visit the Hospital. However, the husband is reluctant as the hospital costs money and he is too poor even to feed his wife. Siri then educates them about government schemes available under the like government hospitals, Anganwadi, KCR kit, Kalyana Lakshmi, shadi Mubarak etc. Similarly, from the birth of the girl child Asha, she educates them on Beti Bachao Beti Padao Andolan, Right to Education of child, Various financial Assistance offered to promote education, and equal Opportunity. Woman Reservations, Maternity Benefits, Equal Pay for equal work when girl chooses male dominated field for career etc. She also teaches them to speak up for their rights by showing a simple act where she demands bus passenger who occupied a seat reserved for ladies, to vacate it. Here The girl child developed into a stage were, Asha advices her friend on solving her martial problems by visiting Mahila Police volunteer. Though during Pregnancy Asha struggles to juggle her martial life and career contemplates resigning job, but with the help of maternity benefits, at the end was Awarded Best Employee of the Year, which makes the father realize that women can be successful by enforcing their rights.

The Conclusion of Skit shows the Development of girl Child from a Helpless little girl, to an independent woman who is outspoken about her rights and inspires others to do the same.



Skit 2:

The summary of the story is as follows:

A small girl lives with her parents. One day her uncle came to stay with them when the father is out of station for work. The mother of the child drops the child to school and picks her up every day. But one day due to some work the uncle is sent to pick her up from school. Since mother was not there at home, uncle takes advantage of the opportunity and gets physical with the child. The innocent girl cries out to get rescued when the uncle threatens to kill the child and mother. Days pass by and the behavior of the girl changes because of the way the incident affected her mentally and physically. One day the girl opens to her neighbor and she brings this to the mother's knowledge. Mother feels guilty of what happened with the daughter, because she trusted her daughter to be safe around the uncle. The parents are reluctant to informthe police, but the neighbor educates them about POCSO Act.

Thus, this skit enactment portrayed the importance of safety of girl child even around the family and the importance of educating about POCSO Act.











Skit 3:

The brief of the story is as follows:

People of different age groups and all generations of a joint family, are addicted to electronic gadgets and drugs. They believe that world revolves around these.

One day the grandfather who is a retired principal; is visited by his friend. It became difficult for grandfather to introduce his family to his friend. Once the WIFI is put off one by one everyone comes out to ask about WIFI; but fail to realize that there is guest at home. The grandfather somehow manages to try and keep them together for a while letting them use electronic gadgets for a limited time.

The skit also depicts about how the young generation is easily getting trapped into the addiction of drugs and how it makes drastic changes into their lives.

The skit enactment was to pass an important message of how addictions makes a person distant from family and how they forget there basic moral values because of all these.



Conclusion:

The legal aid camp was a huge success as the main motive of the camp was justified. The message conveyed through skit enactment and reached out to everyone who were present for the program.
